Organic Membership Termination

QWFC Ltd Welsh Organic Scheme runs on an annual basis based on either land conversion start date or transfer date from another organic certification body. Certificates are issued on a twelve month basis following satisfactory assessments and receipt of annual fees.

Any producer withdrawing from organic certification is required to notify the company in writing. Please note that cancellation cannot be after current certificate expiry date unless payment and assessments are up to date.

Grant contracts with the Welsh Government are totally separate to your agreement with QWFC Ltd. Any producer withdrawing from organic certification with QWFC Ltd should check with their local Rural Payments Office to ensure that cancellation of their QWFC Ltd membership does not affect their contract with the Welsh Government.

THE FUTURE OF ORGANIC FARMING IN WALES

The Welsh Government have announced that following a competitive tendering process, the OCW Partnership led by Organic Research Centre (ORC) in co-operation with ADAS and Institute of Biological, Environmental and Rural Services (IBERS-Aberystwyth University) have been awarded a contract to provide the policy steer for a new organic support scheme in readiness for the next Rural Development Plan (RDP) for Wales.

The Welsh Government values organic farming as a method for both sustainable land management and high quality food production and will work closely with the OCW Partnership to deliver organic support that best supports the needs of Wales.

ORGANIC MARKET REPORT

The Organic Market Report was published on the 20 March and highlighted key areas of growth in online retail, independent outlets and a shift towards younger consumers during 2012.

There is evidence that consumers are choosing to buy organic as a guarantee of integrity with some independent organic meat suppliers reporting an increase in sales over the last month of up to 20%.

Report findings show organic shoppers are increasingly choosing the convenience and variety offered by online shopping. Independent outlets also saw an increase in sales during 2012 with growth of 0.7%, now valued at £480.6 million. Box scheme, home delivery and mailorder sales saw an increase of 4.4% to £174.3 million.

CERTIFICATION ISSUES

Pre-Inspection Questionnaires

In order to help you prepare for your organic inspection, QWFC Ltd send you the inspection questionnaire together with your field data sheets. These documents indicate the inspection requirements and documentation which the inspector will need to see.

Non-Conformances

The non-conformances most often recorded in the last 12 months:

The average number of non-conformances over the last 12 months was 1.90 per assessment which indicated that the majority of producers are complying with the organic standards.
